THIS RELEASE IS INTENDED TO DISCHARGE EACH RELEASED PARTY FROM ANY AND ALL LIABILITY ARISING OUT OF OR CONNECTED IN ANY WAY WITH RELEASOR'S PARTICIPATION IN THE REGATTA EVEN IF THAT LIABILITY ARISES OUT OF NEGLIGENCE OR CARELESSNESS ON THE PART OF ANY RELEASED PARTY.

Releasers hereby acknowledge that accidents occasionally occur during iceboating activities and acknowledge that mortal or personal injuries and/or property damage or other loss may result from participation in the Regatta. Releasers release all Released Parties mentioned above who might otherwise be liable to Releasers, including further injury sustained as the result of the efforts of third parties who come to the aid of Releaser(s) if injured as a result of participation in the Regatta. Releasers agree to abide by all rules of any Sponsors and the Host in connection with participation in the Regatta.
